**The Alto Town Council held the regular council meeting on November 8, 2022. A work session preceded the meeting to discuss all current projects and the budgets. Christmas Tree Lighting on December 1<sup>st</sup> at 6pm will be lighting the tree, singing and handing out cookie decorating packets outside of City Hall; Employee Christmas dinner will be December 6<sup>th</sup> at 6pm; BC Grant Road project is waiting to be put on Higgins Construction schedule; Apple Pie Ridge well has been shut down with the building remaining, if it is removed, we have to dig down 3 feet according to EPD. Discussion was to either use it as storage or donate it to the property owner; Hodie Meats is preparing to start up the processing company in which they will use a lot more water; Balance sheets through September were passed out by CFO Lisa Turner and explained. GCIC has been so busy that the numbers aren't in yet so everything should be done by the next meeting; she suggested that Officials come by, call or email any questions or concerns to her; fewer od's and the use of narcon was discussed by Chief Ivey; Insurance quotes are being taken due to United Healthcare not being able to settle with Northeast Georgia Medical in Gainesville as of right now, if they don't come to an agreement, they will be out of our network and most employees go to Gainesville.**

**The meeting was then called to order by Mayor PJ Huggins. The invocation was delivered by Pro-tem Eddie Palmer followed by the Pledge of Allegiance.**

**Recommendations from Officers, Departments, and Attorneys:**


**Chief Josh Ivey presented the monthly police totals.**
