**A work session was held at 6pm. Discussions were:
Mayor Armour read uplifting words from a 1902 book with Proverbs of wisdom that she wants herself and the team to operate in for the Town; Mayor seeking approval to move forward in bids/quotes for upgrading park, roads and community center with the funding already available; Wynn Shoals project was already earmarked in the 2023 SPLOST to complete in phases; in order to do a turnaround at White Pine Lane, the property owners have to be contacted for approval to proceed; Banks Co SPLOST capital project list: Apple Pie Ridge water line with hydrants, Garland White Rd line, W Coker Road issue resolved so can use those funds for something else; Habersham Co SPLOST designated for roads-streets-PD-Community Center: Wolf Pen well sold so use those funds somewhere else perhaps another well, upgrade community center to be usable for public, add Health/Fitness equipment to the playground area, swings need replacing and playground upgraded,; 2023 LMIG grant can be used, resurface parking lot at City Hall, add additional parking to accommodate events and monthly court, add Cypress Lane, Nix Road, Tucker Dr and McDaniel Street that need repairs; officials were in agreement to proceed with what needs to be done in an order of importance to complete unfinished projects.**

The regular meeting was then called to order by Mayor Gail Armour. The invocation was delivered by Pastor Scott Ledbetter. Councilman James Turner led the Pledge of Allegiance.
